Dan Schnur, Director of the Jesse M. Unruh Institute of Politics at USC Given the interest nationally in California's economic and political climate, we have invited Mr. Dan Schnur, Director of the Jesse M. Unruh Institute of Politics at the University of Southern California, to be the guest speaker at our June 22 annual membership meeting.

Politics and entertainment are intertwined industries in California, as evidenced by the political careers of actors such as Ronald Reagan and Arnold Schwarzenegger. California is at the forefront of most trends in both entertainment and politics, and the two can affect each other in many ways as movies shape popular opinion and politicians invoke well-known phrases or images from movies to reach their audiences.

New ADA Media Requirements to Be Discussed At Annual Membership Meeting

Greg Hurley of the law firm Greenberg Traurig and Chairman of the firm's ADA practice group, will discuss at the NATO of California/Nevada annual Membership Meeting how exhibitors can conduct and audit their media to comply with new ADA developments on accommodating the blind and deaf beyond captioning. Mr. Hurley will discuss what Exhibitors should be familiar with regarding the opened and closed captioning options available for their feature movies. He will also provide information on how to make marketing materials, web-sites, menu boards, etc., accessible to the blind and deaf. The scope of this obligation is shown by a recent opinion where the second highest federal court found that the Washington Redskins football team must offer transcripts of the lyrics of the songs that the team plays over the PA system as well as a recent settlement by Wells Fargo Bank to pay \$16 million to settle claims about ADA access for blind & deaf to its phone services, ATM's, web media, in person services and documents.

Mr. Hurley has prepared media audits for Home Depot, Taco Bell, Fresh & Easy, Little Caesars Pizza, PetSmart, Live Nation and many other national businesses

An Update on The State Of Exhibition


1. Discussion of the political climate in the State Capitol including the potential effects of reapportionment on member outlook, balance of power in the houses and reshaping of California politics.

AB 10 (Alejo) re: minimum wage increasesSB 3AB 400 (Ma) re: paid sick daysSB 6AB 669 (Monning) re: soda tax
